

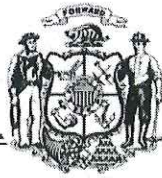

Dear Chair Halbrooks and Vice Chair McCallum:


We are writing to notify you that on December 12, 2017 the Joint Committee for Review of Administrative Rules (JCRAR) held a public hearing on CR 17-038, relating to requests for written advice issued on behalf of the Ethics Commission.

Pursuant to s. 227.19 (5) (b) 2., Stats., JCRAR approved a motion requesting the Ethics Commission to consider modifications to the rule; and further, that if the commission does not provide written acceptance of the request to consider modifications, delivered to the JCRAR co-chairs by 12:00 p.m. on December 19, 2017, that pursuant to s. 227.19 (5) (d), Stats., the Committee objects to Clearinghouse Rule 17-038, on the grounds that the proposed rule is arbitrary and capricious and fails to comply with legislative intent. The motion requesting modifications was passed by 10-0 vote.

The JCRAR specifically requests that CR 17-038 be modified to include the Ethics Commission's internal policy on delegation of commission authority for staff to issue informal opinions in Administrative Code. State statute requires that each agency promulgate as a rule each statement of general policy and each interpretation of a statute that it adopts to govern its administration of that statute.

The Ethics Commission must notify the JCRAR co-chairs in writing whether the commission plans to consider modifications to CR 17-038, pursuant to s. 227.19 (5) (b) 2., Stats., by 12:00 p.m. on December 19, 2017.

On behalf of Chair Halbrooks, Vice-Chair McCallum, and all the members of the Ethics Commission, thank you again for the opportunity to participate in the public hearing on December 12, 2017 regarding CR 17-038, relating to requests for written advice issued on behalf of the Ethics Commission.

In response to your later dated December 13, 2017 regarding the motion adopted by JCRAR regarding CR 17-038, the Chair and Vice-Chair are notifying the JCRAR co-chairs that the Ethics Commission hereby plans to consider modifications to CR-17-038, and specifically to include the Ethics Commissions internal policy on delegation of commission authority for staff to issue informal opinions in Administrative Code.

I would also like to share that the Ethics Commission staff, having been directed by the Chair and Vice-Chair to draft the requested modifications, will be, along with the Chair and Vice-Chair, recommending that the full Commission support the requested modification, and immediately message that modification to JCRAR for review pursuant to Wis. Stat. 227.19(5)(b) 2.

Administrator Bell:

The recent revelations made by the Department of Justice about the John Doe investigation have been deeply concerning.

The voting public must have faith that the watchdog agency of ethics in government can be run without any tint of partisanship, and our creation of the bipartisan commission, in which both political parties are represented equally, was a positive step in that direction.

Unfortunately, due to past errors in judgment by leadership and staff at the recently-disbanded Government Accountability Board, there are still widespread concerns over partisan influence remaining at the top of the Ethics Commission. You have lost the confidence of our caucuses to be an impartial administrator.

Therefore, we believe that it would be appropriate at this time for you to tender your resignation to the Ethics Commission board.
