Governor Evers delivered his budget address on February 15, 2023. At his request, the Joint Committee on Finance introduced <u>Assembly Bill 43</u> and <u>Senate Bill 70</u> relating to: state finances and appropriations, constituting the executive budget act of the 2023 Legislature.
