Governor Evers delivered his budget address on February 18, 2025. At his request, the Joint Committee on Finance introduced <u>Assembly Bill 50</u> and <u>Senate Bill 45</u> relating to: state finances and appropriations, constituting the executive budget act of the 2025 Legislature.
