## Officials Required to File

Of the approximately 2,500 state officials subject to the Ethics Code's standards of conduct, about 2,100 officials—generally, those holding salaried positions and those whose appointments require the Senate's consent\*—file Statements of Economic Interests. Candidates and nominees for state public offices also file Statements of Economic Interests. Statements are open to public inspection.

\**Exceptions: Bradley Center and Professional Baseball Park Board Members do not file.*
