WIS. STAT. §§ 19.50No employee of the Commission may disclose information related to an<br/>investigation or prosecution under ch. 11, subchapter III of ch. 13, or ch. 19.

- WIS. STAT. § 19.85(1) Any meeting of a governmental body, upon motion duly made and carried, may be convened in closed session under one or more of the exemptions provided in this section. The motion shall be carried by a majority vote in such manner that the vote of each member is ascertained and recorded in the minutes. No motion to convene in closed session may be adopted unless the chief presiding officer announces to those present at the meeting at which such motion is made, the nature of the business to be considered at such closed session, and the specific exemption or exemptions under this subsection by which such closed session is claimed to be authorized. Such an announcement shall become part of the record of the meeting. No business may be taken up at any closed session except that which relates to matters contained in the chief presiding officer's announcement of the closed session. A closed session may be held for any of the following purposes:
  - (c)Considering employment, promotion, compensation, or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility.
  - (g) Conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved.
  - (h) Consideration of requests for confidential written advice from the elections commission under s. 5.05 (6a) or the ethics commission under s. 19.46 (2), or from any county or municipal ethics board under s. 19.59 (5).
- WIS. STAT. § 19.851(2) The commission shall hold each meeting of the commission for the purpose of deliberating concerning an investigation of any violation of the law under the jurisdiction of the commission in closed session under this section.
- WIS. STAT § 19.851(3) The commission shall convene in closed session for any of the following purposes:
  - (a)To consider whether there is a reasonable suspicion or probable cause to believe that a violation of the law occurred or is occurring based on a complaint and, if received, a response to that complaint.
  - (b)To receive reports concerning audit findings and consider whether there is a reasonable suspicion or probable cause to believe that a violation of the law occurred or is occurring.

#### **Commission Administration**

#### <u>Trainings</u>

Since the last staff report, Commission staff jointly presented at the Wisconsin County Clerks Association meeting in Madison on March 5<sup>th</sup>. Approximately half of Wisconsin's county clerks attended. Commission staff plan to present again at WCCA's summer conference on June 24, 2024. The summer conference will be held in Hayward, and it is expected that many of the clerks that did not attend the meeting in Madison will be present in Hayward.

Additionally, Administrator Carlton presented ethics training to staff of the Wisconsin Legislature on April 25-26, 2024.

Staff Counsel Buerger is scheduled to present a training at the UW-Green Bay Clerks and Treasurers Institute on July 15, 2024. The Clerks and Treasurers Institute is commonly attended by hundreds of clerks from across the state and is part of a 3-year program focusing on the duties and responsibilities of serving as a clerk/treasurer in Wisconsin.

#### **Campaign Finance**

There were 86 candidates required to file a Pre-Election Spring 2024 report. There were 3 filed late and 2 candidates that failed to file the report. Settlements have been issued.

The next required report for all committees and conduits is the July Continuing 2024 report. This report will cover all activity through June 30, 2024, and is due by July 15, 2024. Staff have been testing the new website and continuing to conduct audits on contribution limits, cash balances, missing information.

#### Lobbying

#### 2023-2024 Legislative Session

Registration for the current session is available on the Commission's lobbying website. As of May 1, 2024, there are 732 lobbyists licensed, 888 principals registered, and 2,010 lobbyist authorizations.

#### **Code of Ethics and Financial Disclosure**

#### Statements of Economic Interests (SEIs)

2,202 officials were required to file an annual SEI by April 30, 2024. All but 90 filed on time. As of May 1, 2024, 72 SEIs remained outstanding. The SEIs for candidates at the fall election will be due by 4:30 p.m. on June 6, 2024. As of May 1, 2024, 125 non-incumbent candidates have registered for the fall election and been pulled into the SEI system.

#### State of Wisconsin Investment Board Quarterly Reports

The 2024 first quarter reports covering January to March were due on April 30, 2024. All but two of the 59 filers filed on time. The second quarter reports covering April to June will be due on July 31, 2024.
